The administrative recommendations of Garden City Group, LLC ("GCG" or "Claims Administrator"), the Court-appointed Claims Administrator, to accept the Proof of Claim and Release forms ("Proofs of Claim"), including the late but otherwise eligible Proofs of Claim, listed in Exhibits B-1 and B-2 to the Affidavit of Stephen J.
